Re: (Non-) Identification for Sovereigns

Winsum, 9. July 2012

In reply to your letter of June 19th I write to you again with regard to the matter of identification for Sovereigns.

You state that: *"If you would like to travel with KLM, you always have to be in possession of a valid travel document, a passport or a dutch identity card. If you do not have such documents, you are not allowed to travel."*

First of all I want to stipulate that I write to you as a Sovereign Man of Flesh and Blood and go by the name of Maarten; of the family Lusink and that is not under the title of Mr.!

The name MAARTEN LUSINK is copyright protected and I ask you not to use that name anymore without my written consent. Using that name and/or any derivative thereof in any way without my written consent will result in me presenting you a bill which will amount to €20.000,- (twenty thousand euro) for every time you use that name and/or any derivative.

Second of all I am not sure I have to remind you of your duties as a Dutch citizen (supposing you are a Dutch citizen) or to the Duties of KLM participating in commerce as a legal entity within the State of the Netherlands.

Are you (and/or KLM) aware of the fact that each legal entity within the State of the Netherlands has to uphold the Dutch Constitution?

Are you (and/or KLM) aware of article 94 of the Dutch constitution?

- Statutory provisions within the Kingdom shall not apply if such application is not compatible with any binding provisions of treaties and of resolutions of international organizations.

Are you (and/or KLM) aware of articles 4 and 20-2 of the Universal Declaration of Human Rights?

*- No one shall be held in slavery or servitude; slavery and the slave trade shall be prohibited in all their forms.
- No one may be compelled to belong to an association.*

Legal dictionaries define slavery as:

When a person (called master) has absolute power over another (called slave) including life and liberty.

Legal dictionaries define association as:

A form of organizational structure for a defined group of individuals, for a religious, scientific, social, literary, educational, recreational or benevolent or commercial purpose.

The State of the Netherlands fits perfectly within that last description, doesn't it?

So ...

Doesn't your statement imply that one has to be part of or belong to an association?

And since I have stated in my previous letter that I am not to be considered a Dutch citizen but a Sovereign Man, doesn't your statement imply that article 4 of the Universal Declaration of Human Rights is to be disregarded?

As the answers to these questions seem blatantly obvious to me, maybe you (and/or KLM) would like to reconsider the statement done by your letter of June 19th, 2012?

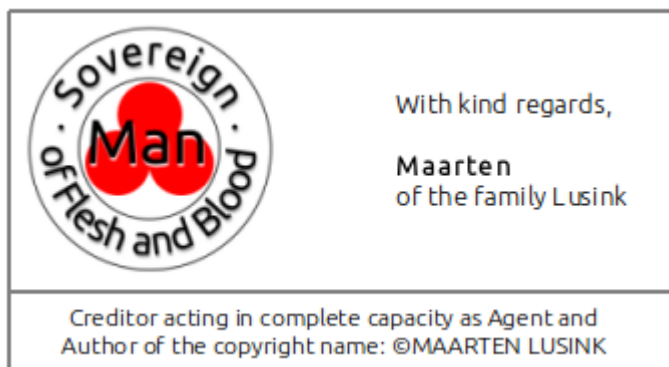
To that end I again state the following:

Now that I have claimed my rights as a Man by means of the Universal Declaration of Human Rights, I have returned all documents that had been issued by the Dutch Government. Therefore I won't be able to use their passport anymore (or any of their identification cards for that matter). However I would like to be able to go around the world as I please, using services such as yours for example.

Since I am now a Sovereign I live outside of statutory law systems and I cannot provide you with a passport or any such document used for identification created by any state/country. I would be happy though to provide you with a copy of my Life Birth Record as means of identification and/or willing to sign contracts/treaties with you to give you all the assurance of my good faith and good intentions as you may need.

Therefore in conclusion, would you (while upholding the Dutch Constitution and the Universal Declaration of Human Rights) be so kind as to let me know how I as a Sovereign Man would be able to make use of your services?

I take it that you understand all I have stated above, in case you would need more clarification I would be happy to provide you more information to do so.
