

# 1. The Enormous Small Lie

For years, decades or maybe even centuries we have been lied to regarding our rights and duties, and in such a simple manner that it sounds really ridiculous! When you sit down and have a look at it in retrospect, it is actually funny to see how this lie has permeated all parts of our lives, even our languages (or maybe we should say by means of our languages).

There are several ways to start to explain this, but let me start with this question:

Do you know that there is a significant difference between the words person and human (/man/woman)?

Although or maybe because we have been taught that they mean the same, the difference in meaning between these words is of the utmost importance for our freedom or our bondage!

The meaning of the word person is derived from the Latin word persona<sup>1</sup>, which comes down to: - a mask (a role or a character played by an actor)

A human is a man or woman, a sentient being of flesh and blood.

Besides that the word 'woman' may stem from the word 'wombman', therefore the word 'Man' stands for 'man' as also 'wombman'. Thus we shall henceforth use the term 'Man' instead of 'human'.

Thus the lie is: a Man is a person

## 2. Law and Justice

Now how could the knowledge of this difference help us one bit further, you may ask.

If you look closely in your constitution and law books (i.e. legal system), you'll most probably notice that the constitution sometimes refers to Man and sometimes to persons and that the legal system always refer to persons.

And yes, this most probably already means that the legal system doesn't apply to Man, it only applies to persons.

But of course we wouldn't want to claim certain rights on these 'assumptions' only!

Most (if not all) acknowledged countries in the world have signed up with the United Nations and as a result they are obligated to add a certain article into their respective constitutions. They must add an article stating that in case certain laws conflicts with signed rules of international treaties, then the treaties' rules precede.

Be sure to look this up!

In the Dutch Constitution (Grondwet), this can be found in article 94: Statutory provisions within the Kingdom do not apply if such application is not compatible with any binding provisions of treaties and of resolutions of international organizations.

When we have a look at international treaties and or resolutions of international organizations, then we also should notice the following important "Rights":

- the Universal Declaration of Human Rights (UDHR)
- the International Covenant on Civil and Political Rights (ICCPR)
- the European Convention on Human Rights (ECHR)

You should feel the urge now to read these carefully!

But to start of, notice article 6 of the UDHR:

"Everyone has the right to recognition everywhere as a person before the law"

In short this already implies that in law there is a difference between a Man and a person, as also that the legal system only applies to persons.

#### 3. An invalid contract

As in most 'civilized' countries, one of your parents went to a local office of 'your' government upon your birth to have your Life Birth Record (geboorteakte) signed by both your parent as well as a servant of 'your' government as proof of you having been born into this world. In common law territories this is called a trust (agreement).

So far so good, most would say ... even although 'the Creator' has never asked anyone to show proof of having been born, because the mere fact of your being is already proof of you having been born! But who cares, if someone wants to have a paper as proof of having been born then that is his/her right!

Something could be written here about the difference(s) between Maritime Law and Laws of the Land (Civil Law, Common Law & Religious Law), but that's for you to sift through if you choose to see it as important.

After the Life Birth Record (LBR) has been signed the first 'funny' thing happens, although you are the rightful owner the original version is to be administered by 'your' government. Why didn't you get it, instead of you only being able to buy a copy?

Then the next funny thing happens. As the administrator/trustee, the government creates a person<sup>2</sup> (which upon first sight bears exactly the same names as is written on your LBR) into their system (aba – gemeentelijke basis administratie) combined with a social security number. Mind you, you as owner of the LBR have never been asked if they were allowed to do that! Neither have they given you (part of) the profit gained from taxes imposed on that person, even though you as owner of the LBR have title/right to bear the fruits gained from or as a result of your property (that LBR).

From that day on you are taught that you are the same as the person ... which doesn't seem strange because everybody (even your parents) tells you that you are a person ... to be precise, that person. So you act as if you are that person, because you don't know any better.

When some governmental agency or any other company sends a letter addressed to 'your' name in uppercase letters which arrives to your house, then you automatically assume it is addressed to you although it is actually addressed to the person.

When some public servant stops or holds you and asks you for your identification and you give him/her a personal identity card given/issued to you by 'your' government, then (because you assume to be the person) that governmental employee can assume you to be that person, therefore the laws apply to you and you are of lower rank than that 'officer' ... thus you have to follow his/her orders.

But as you should have learned already ... to assume makes an ass out of u and me!

Are you aware of the fact that most (if not all) legal systems have rules for contracts, which often state that a unilateral contract is illegal! Which means that if someone says that you have a contract between the both of you and you have never agreed to that contract, that it has no legal basis Did you ever agree to or sign a copy of a contract which makes you part of a country (by means of a person)?

Nope. I didn't think so ... so already by pointing out their own laws, their laws show not to be applicable to you ... unless they could prove you agreed to the contract, but that is very difficult to do as long as they cannot provide a 'payslip'. Moreover it is very easy to prove they led you to believe the contract (i.e. to believe you are the person), since they never have informed you of the opposite!

Besides that the UDHR articles 4 and 20-2 state the following:

"No one shell be held in slavery or servitude"

"No one may be compelled to belong to an association"

Which in short means that already on basis of those two articles of the UDHR one can cancel a contract at any given time.

Therefore although maybe you chose to believe there existed a contract between you and the country you live in, if you so choose you can cancel that contract immediately ... which makes it an invalid contract!

This person (the legal entity) can be recognized by its name being written in all uppercase letters (Capitis Diminutio Maxima), or any other form of it in connection with the social security number.

#### 4. Trusts Visualized

In common law territories one speaks about trusts, when in civil law territories we speak about agreements and contracts. In the end it doesn't matter a great deal, since there are often international treaties in place which nullify the differences between the two. Like for example 'the 15th Haque Convention' of 1985 delivered the 'Trust Treaty' (http://www.hcch.net/index\_en.php?act=conventions.text&cid=59).

In trusts one is always confronted with 'the holy trinity', where the trust is held between a Beneficiary, Administrator and a Trustee.


The Beneficiary is like the shareholder, he/she enters value into the trust.

The Administrator also known as the Executor, takes the value in trust and makes sure the trust is held

The Trustee is a hired hand, keeps the trust and has to follow the rules as stated by the Administrator for the benefit of the beneficiary.

To keep things short ... the Beneficiary always is in control of the trust and decides who is to be the Administrator as well as the question if the delivered service is up to his/her standard and if the benefits are as wished/expected (i.e. good enough). #### How to be a free Man 5.

Now that we not only know that we're being fooled but also how we're being fooled, the question is how we can become free Men if we would like to become free.

First of all you should ask yourself if you truly are ready to become a Man free from manmade rules?!

For example are you sure you can and want to go about without an insurance, without a mortgage, without social security, without a passport, without a bank account, without a drivers license and so on ... I.e. do you need someone or something (like a company or state) to hold your hand to go through life?

Are you sure you are a responsible being, do you care for others as you care for yourself and don't (want to) do harm unto others or their property, do you take matters into your own hands if need be to correct any mistake made?

If you hesitate answering on anything stated above or plainly don't agree, then I would suggest you remain being a state citizen ... because that is most likely the 'place' where you would find the re-assurance that you seek/need.

In case you have an aggressive attitude towards other people or are just (by nature) a criminal, then I strongly suggest you remain being a state citizen ... because punishment through 'national' laws usually tend to be less severe than punishment through 'international' laws, moreover the state normally also pays for it (since they actually are the owner of you -the person-).

If however you feel you finally found the road to enlightenment (so to speak) and in your heart you already are a Freeman, then you only have a few steps to take to 'officially' become a free Man. Actually you already are a free Man, but you have unknowingly been using your human rights as stated in the Universal Declaration of Human Rights, like the right of having recognition as person before the law (Art.6) and of having the right to a nationality (Art.15) ... only ever since your birth the state assumed you were aware of you using your rights and since you never informed them of the opposite they had no (logical?) reason to assume otherwise.

And as made clear before, to assume makes an ass out of u and me! So let them be an ass if they choose to be one, but you on the other hand should know better now;)

All you have to do is inform the highest ranking 'official' in your government (i.e. the head of state: the Prime Minister, the President, the King or the Oueen) that you are refraining from using your right of having a person and from then on are to be considered a 'Sovereign Man of Flesh and Blood' (a.k.a. Freeman on the Land) ... over whom they have no jurisdiction what so ever!

Here in the Netherlands we have created some steps (formal letters stating claims) as to make clear to the Queen and the State what we are and that we -Sovereign Men of Flesh and Blood- are outside their jurisdiction, also according to their own legal systems.

Prepare yourself and know that you are in the highest jurisdiction possible on this planet as to which they cannot touch you if you haven't done wrong to any other Man!

As for being stopped by any SERVANT, just get it into your mind and heart that you are their master by law ... they are not yours (anymore)!

Get some paperwork ready to have the lines you want to say easily available or maybe even to hand out to that SERVANT and make sure you have all on camera ... that way you can prove when they step on your human/natural/birth rights!
